To all who shall see these Presents-GREETING:

Know Ye, That on the 13th day of October Anno Domini 1899 at a Probate Court, held at the Probate Office, in the City of Toledo, in and for said County of Lucas, and State of Ohio, personally came Ignac Stackah a native of Germany and proved to the Court that he had arrived in the United States before he had attained the 18th year of his age, and made the requisite declaration of his intention to be NATURALIZED, and become a Citizen of the United States; and also proved, to the satisfaction of the Court, that he has behaved as a man of good moral character, attached to the principles of the Constitution of the United States, and well disposed to the good order and happiness of the same. And having fully complied with the laws of the United States in relation to the Naturalization of Aliens, and on being admitted by this Court, took the oath to support the Constitution of the United States of America, and to Absolutely and Entirely Renounce and Abjure all allegiance and fidelity to every Foreign Prince, Potentate, State or Sovereignty whatsoever, and particularly to the Emperor of Germany whose subject he was.

This is, therefore, to Certify, That the same Ignac Stackah is admitted a CITIZEN OF THE UNITED STATES.

D. 1877; that at the time I so arrived, I had not attained the eighteenth year of my age, and that for three years last past, it has been bona fide my intention to become a Citizen of the United States, and to renounce forever, all allegiance and fidelity to every Foreign Prince, Potentate, State or Sovereignty whatsoever, and particularly all allegiance and fidelity to the Emperor of Germany whose subject I am.
